## Location

## Description

The restaurant comprises a detached two storey steel framed building beneath a flat roof. Externally there is a seating terrace to the front elevation.

## Accommodation

The premises are configured to provide accommodation at ground and mezzanine floor levels and are laid out to provide a variety of tables and seating for circa 144 customers. Ancillary accommodation includes a catering kitchen with prep area and walk in fridge and freezer, and thermostatically controlled beer cellar and mezzanine level providing staff facilities and customer toilets.


