Regular buses also run from Chiswick Lane towards Chiswick High Road. Chiswick Gate is within close proximity of the beautiful Chiswick House and Gardens, and the River Thames. Chiswick offers easy access to central London via the A4, as well as access to Heathrow and the west of England via the M4.

About this property

Situated on the first floor of this landmark development, this two bedroom apartment is immaculately presented with a fabulous Southerly facing balcony, landscaped communal gardens and an onsite Concierge (7am-7pm, 7 days a week). There is also a residents Gym.

Upon entry, the hallway is wide and spacious with integrated storage utilities. You are greeted by the bright kitchen/reception room which has wooden flooring throughout and is awash with modern appliances. The room is naturally light and spacious with the added bonus of access via the reception room and the kitchen out to the good size southerly aspect balcony with views over the well-maintained communal gardens, ideal for entertaining.

The principle bedroom is of a good size and is equipped with substantial built-in wardrobes and a fabulous en suite bathroom.


