LOCATION

14 Murrayfield Avenue is set within the Coltbridge & Wester Coates Conservation Area of the much sought after suburb of Murrayfield. This area is within walking distance of the city centre and Haymarket Station and is particularly popular with families being superbly positioned for schools including St George's, Erskine Stewart's Melville school and Fettes College. There are excellent amenities close by including the Roseburn Park, picturesque walks along the Water of Leith and a good range of local shops within easy walking distance in Roseburn. There is also convenient road access to the west connecting to Corstorphine, Edinburgh Park, Edinburgh Airport and the Central Scotland motorway network.











PROPERTY DESCRIPTION

14/1 Murrayfield Avenue is an immaculately presented and recently refurbished ground and first floor portion of a substantial terraced Victorian house. The property offers spacious, bright and comfortable accommodation finished to a high specification. With both east and west facing aspects the property benefits from plenty of natural light throughout the day. The property retains much of its original charm with many fine period features yet caters perfectly for modern family living. Of particular note is the impressive kitchen with Aga, opening to the dining and family living space which in turn opens to the west-facing garden. From here there is a spiral staircase to the study, while to the front of the house lies the bay-windowed, elegant drawing room. On the first floor there is the master bedroom which also has a beautifully appointed en suite bathroom, while there are two additional double bedrooms are west-facing and are served by a family bathroom. Additionally, there is guest bedroom with en suite shower room on the ground floor.

The property benefits from a generous west-facing garden which has a central lawn and colourful borders surrounding. To the front of the property there is an additional, easily maintained garden.






FLOORPLANS
