Makepeace Mansions lies in a conservation area and forms part of the Holly Lodge Estate which is a gated development built in the 1920's originally as Lady Workers' Homes for single women moving to London.

Local Information

Makepeace Mansions is a distinctive planned development in the Garden Suburb tradition dating to the interwar period located on the upper part of the south facing slopes below Highgate Village. This location is extremely popular with the numerous cafes and shops on Swains Lane and direct access onto Parliament Hill Fields and Hampstead Heath. There are plentiful bus services from the bottom of Swains Lane as well as Tube connections slightly further afield at Kentish Town (Northern Line).


