Discretely tucked away behind a large front garden sits a fabulous Georgian two bedroom house, which was once the home of Dame Edith Sitwell DBE a British poet and critic. Now offered to the market for the first time in over 60 years this wonderful period property requires modernisation, yet retains all the charm and character of the era with attractive aspects both front and rear.

Keats Grove is famous for the writer's house museum and extends approximately east to west from South End Road to its junction with Downshire Hill. This wonderful location is within easy reach of the local amenities along South End Road, including a fantastic selection of cafes and restaurants in Hampstead Village and Belsize Park.

Hampstead Heath is within 150 metres of the property with local transport links available at Hampstead Heath Overground (0.3m) Belsize Park (0.7m) and Hampstead (0.9m) underground stations.


