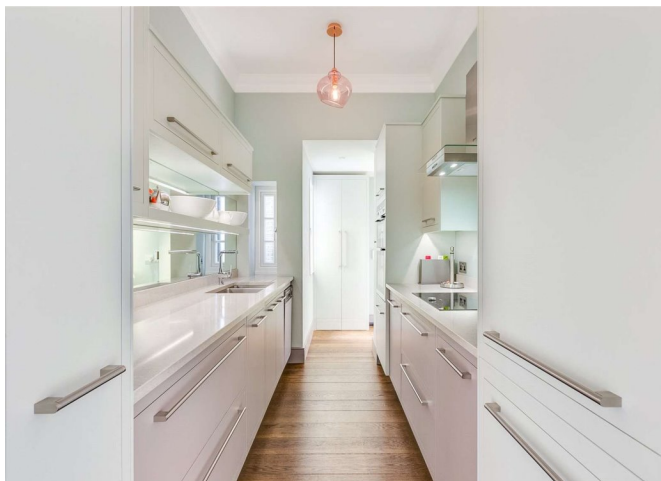

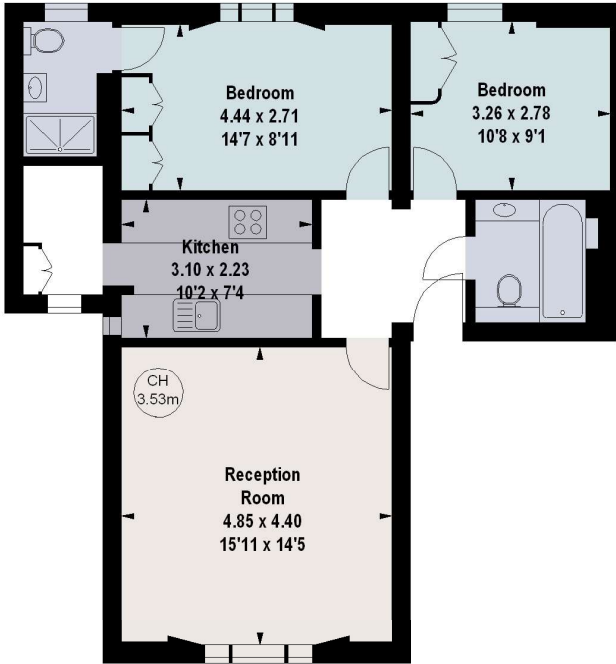

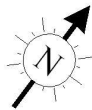

Raised Ground Floor

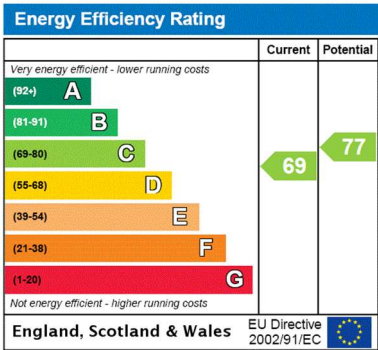
