The entrance hall leads to a superb spacious kitchen/breakfast room with separate utility room to the rear. On the opposing end of the ground floor is a large sitting room and from the hallway in between are two ground floor bedrooms and a study.

The first floor features three double bedrooms, one with ensuite shower room, and a large family bathroom.

The rear garden backs onto woodland and is mainly

laid to lawn. To one side is a timber framed office/ workshop and to the opposing side, a timber summer house and garden shed.
