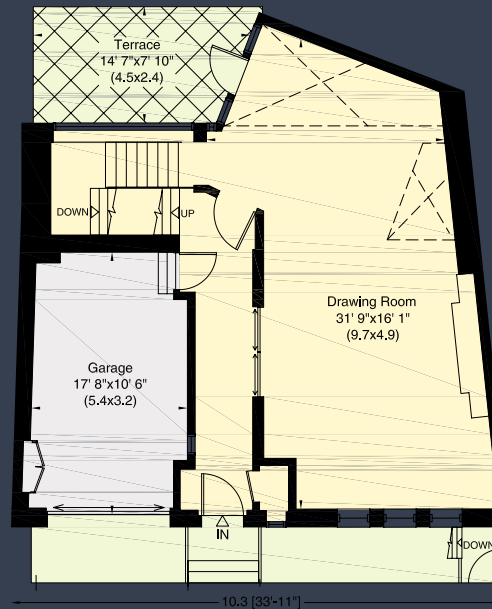
Second Floor



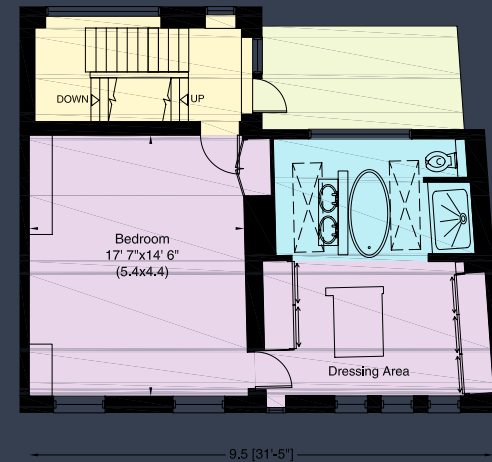
Third Floor
