13th century manor house with access to 100 acres of stunning parkland and at the heart of a 2,000 acre estate; comprising lakes, woodlands, farms, walnut groves and orchards; close to the county town of Taunton, Somerset.

The accommodation includes 13 characterful bedrooms, with an additional 4 bedrooms on the ground level of the newly renovated south wing in close proximity to the main house.

At the ground level, the Ball Room has been converted into two beautifully decorated period drawing rooms together with large dining room library, cloakrooms, grand panelled entrance hall and large kitchen (which is more commercial in nature).

The property and furnishings are steeped in history with some artefacts dating back to the Roman period and secret passages; hidden staircases add to the charm. Maunsel House is a wonderfully welcoming home, beautifully furnished with more than a touch of eccentricity!
