Situation

Dormer House is situated in an elevated position on the edge of the village of Lambourn, with its excellent facilities. More extensive facilities can be found in Hungerford, Wantage, Newbury and Swindon.

There are outstanding views over the surrounding countryside which is designated an Area of Outstanding Natural Beauty and offers superb opportunities for exploring, whether on foot, bicycle or horse. The Ridgeway national path crosses West Berkshire just to the north of Lambourn.

The Property

Dormer House was originally built c.1930s and has been extensively extended and refurbished to create a comfortable and spacious family home. The accommodation is nicely laid out and ideally suited for a large family, however the flexibility of the layout also lends itself to providing a ground floor annexe with separate access.

Outside

Dormer House is approached from the lane to gravelled parking to the front of the house, a spur of which continues to the rear where the double garage and workshop are located.

The gardens are laid mainly

to lawn with some beautiful and mature mixed borders.


